Such questions will be addressed via the society's website;
- d) A member may only vote by appointing the chairman of the meeting as the member's proxy to vote at the meeting by depositing with the Society an instrument of appointment (also known as "the proxy form") by post to 146B Paya Lebar Rd, #06-01 Ace Building, Singapore 409017, or by electronic mail to <a href="members@ddm.org.sg">members@ddm.org.sg</a>.
